Explanation of Responses:

- (1) 35,475 options are currently exercisable; the balance vests on November 16, 2003.
- (2) Vesting of the options is contingent upon the achievement of an aggressive earnings per share ("EPS") goal established in January 2000. If EPS equals or exceeds \$6.46 per share by December 31, 2003, the options will become exercisable in January 2004. If the EPS goal is not met, then the options instead will vest and become exercisable in 25 percent annual increments beginning in January 2005. However, if the EPS goal is not met, the Board of Directors has retained the discretion to reduce or eliminate future compensation awards to offset this vesting.
- (3) 36,285 options are currently exercisable; 18,142 options vest on November 21, 2003 and 18,143 options vest on November 21, 2004.
- (4) 18,904 options are currently exercisable; 18,904 options vest on November 20, 2003 and November 20, 2004 and 18,905 options vest on November 20, 2005.
- (5) The options vest in four annual installments as follows: 20,415 options vest on January 21, 2004, January 21, 2005, and January 21, 2006 and 20,416 options vest on January 21, 2007.

LIMITED SIGNATORY POWER

By this Limited Signatory Power the undersigned authorizes and designates each of Ann Kappler and Scott Lesmes to execute and file on behalf of the undersigned all Forms 3, 4 and 5 (including any exhibits, attachments and amendments thereto) that the undersigned may be required to file with the Securities and Exchange Commission as a result of the undersigned's ownership of or transactions in securities of Fannie Mae.
